NOTIFICATION

In exercise of the powers conferred by section 9B, sub-section (4) of section 15 and 15A of the Mines and Minerals (Development and Regulation) Act, 1957 (Central Act No. 67 of 1957), the State Government hereby makes the following rules further to amend the Rajasthan District Mineral Foundation Trust Rules, 2016, namely:-

1. Short title and commencement.- (1) These rules may be called the Rajasthan District Mineral Foundation Trust (Amendment) Rules, 2019.

(2) They shall come into force from the date of their publication in the Official Gazette.

2. Amendment of rule 2.-In sub-rule (1) of rule 2 of the Rajasthan District Mineral Foundation Trust Rules, 2016, hereinafter referred to as the said rules,-

- (i) in clause (viii), after the existing punctuation mark ";", the expression "and" shall be added;
- (ii) in clause (ix), for the existing expression "; and", the punctuation mark "." shall be substituted; and
- (iii) the existing clause (x) shall be deleted.

3. Amendment of rule 3.-In rule 3 of the said rules, for the existing expression "Zila Parishad", the expression "District Magistrate" shall be substituted.

4. Amendment of rule 5.-In table appearing below sub-rule (1) of rule 5 of the said rules,-

- (i) in column number 2 against serial number (i), for the existing expression "Zila Pramukh", the expression "District Magistrate" shall be substituted.; and
- (ii) the existing serial number (ii) and entries thereto shall be deleted.

5. Amendment of rule 9.-In rule 9 of the said rules, the existing sub-rule (2A) shall be deleted.

6. Amendment of rule 15.-In sub-clause (C) of clause (II) of sub-rule (3) of rule 15 of the said rules, for the existing expression "Following State Level Empowered Committee shall take decisions regarding the above mentioned purpose:-

- (a) Chief Secretary
- (b) Principal Secretary, Mines & Petroleum
- (c) Secretary, Forest
- (d) Secretary, PWD
- (e) Secretary, Social Justice & Welfare
- (f) Secretary, Medical & Health
- (g) Director, Mines & Geology

- (i) Additional Director (E&D), DMG.
- (j) Additional Director (Administration), Directorate of Mines and Geology", the expression "Following State Level Empowered Committee shall take decisions regarding the above mentioned purpose:-

- (i) in sub-rule (3), for the existing expression "Zila Parishad, District Administration", the expression "Office of the District Magistrate", shall be substituted.
